## Restore factory value after power on

Plug the power in the box into the socket, and a small head on the other end of the power supply is inserted into the DC hole of the main engine. Long press the "SETUP" button in the standby state. Then the screen shows "F1" and press "UP" button to "F2", press "ENTER" once to make sure the host appears "0001", in which the bit of digital tube is flashing, and press "DOWN" button to make the screen display as "0000", then long press "CLEAR" button, at the same time, the number on the screen is beating automatically, which means it is recovering Factory value, the host screen is restored to standby state after cleaning.

## Set the time F1

- 1. Long press "SETUP" button, the screen shows "F1"
- 2. Short press "ENTER" button to shift, press "UP/DOWN" button to select current time of year, month, day and week.
